INNOVATIVE LEVEL ONE HEART ATTACK PROGRAM: NO PATIENT EXCLUDED FROM TREATMENT*

Since implementing the Level One Heart Attack Program in March 2003, the Minneapolis Heart Institute® at Abbott Northwestern Hospital has treated 2,639 patients using this unique treatment which is the first of its kind in the United

States to coordinate community emergency departments with trained emergency transportation professionals and an expert angioplasty team available 24/7. When compared to benchmarks, the Level One program shows a significant reduction in mortality rates.

*No patients excluded based on age, cardiogenic shock, cardiac arrest, comorbidity, etc.

2. Zone 2: Hospitals 61-190 miles from Abbott Northwestern Hospital. Half-dose thrombolytic therapy followed by immediate transfer and stenting.
3. Patients entering the Level One Program through Abbott Northwestern Hospital's Emergency Department.
4. Excludes patients with cardiac arrest, cardiogenic shock, age ≥ 80, or COD that is non-cardiac related.
